## **NEWBORN HEARING SCREENING**

Hearing loss occurs in newborns more frequently than any other health condition for which newborn screening is currently required. Moreover, early detection of hearing loss in a child and early intervention and treatment before six months of age has been demonstrated to be highly effective in facilitating a child's healthy development in a manner consistent with the child's age and cognitive ability. Eighty percent of a child's ability to learn speech, language and related cognitive skills is established by the time the child is 36 months of age, and hearing is vitally important to the healthy development of such language skills. Appropriate screening and identification of newborns and infants with hearing loss will facilitate early intervention and treatment in the critical time period for language development.

As such, laws have been instituted to require that each newborn has his/her hearing tested (NEW JERSEY PERMANENT STATUTES 26:2-103.3a & 103.4). However, it is preferable that the newborn hearing screening is done at least 24 hours after birth. Patients delivering at the birthing center will almost never be at the facility 24 hours after birth. As such, the policy of Our Birthing Center is to refer patients to an outside audiologist who can perform the newborn hearing screening and report the test results to the State as mandated.

We have teamed up with renowned Audiologist Doris A. Rapisardi of Styletone Hearing Care, LLC who has extensive experience with newborn hearing screening. Her office is located at 860 Rt. 10 West, Randolph, NJ 07869. The office can be contacted at 973-927-3433.
